A. Engineer Steve Shealey- Easement key map discussion

Engineer Steve Shealey said there have been 37 parcels identified. He has been able to mail out all letters except for 4. The 4 are owned by Tenold. He says they are making progress. A big one was DOT and may or may not agree to easement but may draft their own.
